



# Gazette Notification on Manner of Tax Payments

April 2024



The Commissioner General of Inland Revenue (CGIR) has prescribed the following methods for tax payments as per the Gazette Notification no 2378/33 dated 04 April 2024 issued under Section 145 (3) of the Inland Revenue Act No 24 of 2017 and Amendments thereto:-

- (a) By depositing cash
- (b) By depositing pay order or bank draft
- (c) By the use of Online Tax Payments Platform (OTPP)

Hence, tax payments via cheques is not a prescribed tax payment method by the CGIR

##### MANNER OF TAX PAYMENTS

Tax payments shall be made to the Commissioner General, only by the use of following methods:-

- By depositing cash;
- By depositing pay order or bank draft;
- By the use of Online Tax Payments Platform (OTPP).
